The Marcellus Shale natural gas deposits represent one of the most promising economic development opportunities the Appalachian region has seen in decades. BACKGROUND

The MSC and its member companies are fast-moving and dynamic organizations, and as a result the MSC is seeking individuals who work in a manner consistent with its culture. At present, the MSC is a growing yet nimble organization, strategically expanding its presence to meet the needs of the members in the industry.

POSITION OVERVIEW

The Marcellus Shale Coalition (MSC) is looking for a candidate who will focus on tracking shale gas industry performance, provide strategic evaluation, and convert data, trends and business knowledge into information that is both value-added and timely. This position reports directly to the EVP, Technical Affairs. Serving multiple MSC office and event locations, the Analyst will based in the MSC's corporate office. The need for this position is immediate and we anticipate having the Oil and Gas Industry Analyst begin their work no later than April 2012.

More specifically, the Oil & Gas Industry Analyst is responsible for:

- Working directly with the EVP, Technical Affairs, in the collection of data and maintenance of standard reports including identification of sensitivities, risks, opportunities and strategies
- Executing all phases of primary research projects—both qualitative and quantitative—including RFP's, sampling, data preparation, survey development and programming, fieldwork monitoring, data analyses, and reporting
- Performing various statistical analyses for primary market research projects, e.g., key driver analysis, regression, correlations
- · Advanced analytics (manipulating complex datasets, probing deeply to interpret data)
- Providing timely and accurate weekly, monthly, quarterly and year-end reporting and analysis of health, safety, and environmental data
- · Recommending and implementing solutions to moderately complex issues and assignments
- · Collecting, analyzing data, and authoring market studies

- · Communicating with members to understand and document MSC data
- · Conducting in-depth data analyses using traditional and advanced methods
- · Analytical oversight and review of project initiatives
- Market-focused analysis and support, as directed
- Formulating analysis plans
- Authoring reports containing actionable recommendations
- Developing relationships and conducting interviews with industry experts, major manufacturers, supply chain members, and end-users
- · Developing and delivering professional presentations while answering questions and instilling confidence

- · Assisting with day-to-day business via reporting and ad hoc inquiries
