

Federal Motor Carrier Safety Administration Workshop June 6, 2013 Marcellus Shale Coalition Offices, Pittsburgh, PA

The Federal Motor Carrier Safety Administration (FMCSA) and Marcellus Shale Coalition are pleased to offer to all oil and gas industry stakeholders the opportunity to attend a workshop on Compliance, Safety, Accountability (CSA) System, Compliance Review Investigation and how to comply with Drug and Alcohol Testing Requirements.

Part One: Compliance, Safety, Accountability (CSA) System Overview

The Compliance, Safety, Accountability (CSA) Operational Model is the new way the Federal Motor Carrier Safety Administration (FMCSA) and its State Partners implement commercial motor vehicle compliance and enforcement programs. CSA affects carriers transporting passengers or cargo in interstate commerce, and carriers of hazardous materials in intrastate commerce, but may also include carriers whose State requires that they obtain a U.S. DOT Number. The three major components of the CSA Operational Model will be examined and discussed:

- 1. **Safety Measurement System:** CSA measures safety performance in new more comprehensive ways using inspection and crash results to identify carriers whose behaviors could reasonably lead to crashes.
- 2. Intervention Process: CSA helps FMCSA and its State Partners correct high-risk behavior by contacting more carriers and drivers with a comprehensive intervention process. This intervention process is designed to more efficiently and effectively correct safety deficiencies by tailoring the Safety Investigator's process to the carrier's specific safety problem(s).
- 3. **Safety Ratings Process:** CSA proposes a safety fitness determination methodology that is based on roadside performance and crash data.

Part Two: What is a Compliance Review Investigation and How to Comply with Drug & Alcohol Testing Requirements

A Compliance Review is an on-site investigation of a motor carrier's operations by a U.S. federal safety investigator to determine a motor carrier's safety fitness. Learn what areas are investigated and what steps a carrier should take to ensure compliance with applicable Federal Motor Carrier Safety Regulations (FMCSRs). This session will then be followed by a discussion covering the regulations applicable to the Controlled Substance and Alcohol Use and Testing requirements. This is one area of the FMCSRs where many carriers are found to be in substantial non-compliance and are subject to enforcement action.
