Each participant will gain a better understanding of the management requirements to effectively coordinate and support the response activities during an unconventional oil and gas well emergency.

Visual aids from actual incidents will be utilized to review and discuss effective management processes and breakout sessions will allow detailed discussion in a smaller group setting.

Well Control & Incident Management Workshop Descriptions

Managing a Well Control Incident

Incident Case Studies

This session will layout Marcellus based incidents which are both realistic and non-catastrophic to prompt discussion on how to pre-plan or respond. The session will include internal incident management procedures and discuss near-miss actual scenarios with photos, including situations which have been reported in the last 36 months. Lastly, external incidents will be discussed where internal pre-planning had not occurred. The case studies presented will setup the following two breakout sessions which will go into greater situational detail.

Breakout Sessions: Scenario Based Learning Activities

1. Drilling & Completions – Downhole Lessons Learned

This breakout session will focus on detailed examples highlighting safety aspects of drilling and completions. In addition, there will be an interactive discussion on basic planning for unconventional wells, post drilling, post hydraulic fracturing, and including how operators navigate the PA DEP's Barrier Policy.

2. Health, Environmental, Safety and Compliance – Planning and Executing Health and Safety Plans

This breakout session will focus on identifying potential gaps in the planning and execution of well safety plans utilizing real examples. With this as the backdrop, an interactive discussion will be developed following a line of talking points and questions related to the safety plans, operations, local responders, geographic operations, sound controls, and other perspectives of HSE professionals.

Example elements will be discussed, and recommended techniques for working with the media and first responders will be presented.

Industry Perspective: Lessons Learned - Chevron 2014 Incident

Chevron will provide a brief summary of the 2014 incident in Greene County, Pennsylvania and focus on the specifics of their emergency response plan and how it was updated after the incident. In addition, they will present technical lessons learned, interactions with regulatory agencies and emergency officials, and how this helped redefine internal plans and protocols.

Elements of a Successful Well Control Emergency Response Plan

This session will present and discuss the elements of a successful well control emergency response plan, utilizing real examples and incidents, including both table-top and field drills.
